Do Banks Create

and Destroy Money?

The Federal Reserve Bank of New York, in a 1969 publication titled: "MONEY: Master or Ser; vant?" writes: "Although this idea that anyone can "create" and "destroy" money seems strange at first glance to most people, we shall soon see how this can be done".

"But let us remember that, among the financial institutions, only the commercial banks - those that provide their customers, or depositors, with checking accounts - can "create" or "destroy" money."

At this point, it is important to recognize and understand that the banks, specifically the commercial banks DO NOT, and CAN NOT, create (print) the physical Federal Reserve notes paper currency. The type of money the banks create is checkbook "deposit credits" money. Checkbook "deposit credits" money is bank money, and in no way government money. Bank money is nothing more than bookkeeping or accounting, dollar-denominated, "deposit credits" figures, entered into the borrowers' checking accounts, via the bankers' spending, lending and bank investing operations.

Just for a moment ponder, and you can visualize the tremendous open loop-hole to free lunches for the bankers. A bank officer can pay for his lunch with a check drawn on his bank (generally called a cashier's or officer's check) and with that check, indirectly create

"deposit credits" to the credit of the restaurateur's checking account as payment for the banker's accountious lunch or dinner. Even the President of the United States can not swing such a bargain.

The Federal Reserve's publication "MONEY; Master or Servant" continues: "Let's find out something about this checkbook "deposit" money. Therefore, first of all, where does it come from, how does the money the bankers call demand deposits, get into the banks"?

"The answer to your question is that the commercial banks via a precise accounting or bookkeeping procedure create demand (checking account) deposits, via making bank loans and bank investments".

The Republic of Nicaragua

Republic of Nicaragua - population 2.9 million, about the population of the city of Boston, Mass. Population density about 40 people per square mile - against 64 per square mile in the United States. Land area - 57,000 square miles, about the size of the state of Iowa.

Henry (Boar) Kissinger, H.R. Halderman and John H. Mitchell must go to trial for illegal wiretapping back in 1972.

The three judge panel has agreed Morton H. Halperin has the right for a trial and damages resulting from a 21 month illegal wiretap by federal officials. Halperin was a National Security council aide. The interesting part of the story is about newsreporter Hedrick Smith. The judges threw out his damage claim that resulted from illegal wiretapping by the same government official, while stat-ing in the latter case that "there is no dispute that the challenged wiretaps were illegal." However, the panel held that the reporter Hedrick Smith could not recover damages because the defendants could reasonably have believed in 1969 that the need to find sources of National Security disclosures legally justified warrantless tapping of the telephone of reporters and officials.



NYSE Suspends Boesky's Access


NEW YORK (UPI) - The New York Stock Exchange announced late Friday that Ivan Boesky, the central figure in the largest insider trading scandal in history, had been suspended as an electronic arcess member of the NYSE and from association with any NYSE member. The suspension took effect at 4 p.m. EST.

"We took these measures following review of the action brought by the United States Securities and Exchange Commission against Mr. Boesky for insider trading," Robert Birnbaum, NYSE president and chief operating officer, said in a statement.

'Patriots' indicted in armored-car plot; FBI points to mangled hand to illustrate its case

When Monte Dayton Ross raised his right hand to be sworn in, the missing thumb and parts of two other fingers were stark reminders of an alleged plot in which he was labeled the "bombmaker."

Ross's testimony at a bail hearing in U.S. District Court in Phoenix came as problems deepened for the defendants in the Arizona Patriots case Wednesday,

with federal grand-jury indictments saying they might pose a danger to the charging five self-described Patriots in public and might flee if released. connection with an alleged plot to rob an armored car to finance a survival camp for white supremacists.

The wife of one of those defendants was indicted on charges of pointing a revolver at an FBI agent attempting to arrest her

U.S. Magistrate Morton Sitver ordered Ross and two others held without bail,

In the first testimony by any of the defendants, Ross, 22, said that he supported himself by trapping, hunting and working at ranches. Ross lived in a tent about 35 miles east of Kingman, an arrangement his court-appointed attorney, Gregory Jordan, argued was no more

To all NSLF'ers,

On December 5th, 1986, I was found guilty, by a jury of attempting to murder one Neil Ludkenovitch of 2401 Pasadena in Metairie, Louisiana. Ludkenovitch is a local dopehead and he and his friends had been conducting a campaign of harassment against my wife and property, possibly at the instigation

Actually, I can't blame jury for voting as they did, they voted 11-1 to convict, and they needed 10 according to Louisiana law. My attorney, court appointed, was so inept and ill prepared, calling him incompetent is doing him a great service. He didn't produce a single piece of tangible evidence, and the prosecution's witnesses went unchallenged as they went from fabrication to obscure testimony, and back to fabrication. The prosecution was permitted to introduce polities into a criminal trial, obviously not convinced that he could win without doing so. The judge ruled against us on every motion and objection, few as they were, due to my attorney. In short, the cards in this judicial deck were stacked like poker chips. The judge actually registered surprise when the jury poll was taken and it benorm that one furor. World War II veteran, voted for

About two minutes before the trial was to start, a plea bargain was offered to me, it went like this: If I plead guilty to aggravated battery, they would arrange a pre-sentence investigation and based on that, he would not sentence me to more than 10 years. Then came the clincher, If I didn't accept the plea, and if I was convicted, I would not get less than 10 years. I must assume that the judge meant what he said and that is the purpose of this letter. First there are two individuals who need to be men-

tioned: Ray Leahart, who gave us unlimited personal support, and Dave Lillier, an unaffiliated White racialist who testified on my behalf that Ludkenovitch came at me with a shovel handle when I shot him. Since I am facing at least 10 years when I go for sentencing on December 12th, it is important that we make some kind of organizational provisions. Let me say that the action that I am about to outline is not underconsideration, pro's and the con's. My concern is to do what is best for the movement. If we, as a race, are to overcome the obsta-cles ahead of us, we must learn the technique of turning adversity into advantage. That is the key to success.

I have but two real alternatives, namely, to appoint a successor, or to merge NSLF with another group. I did not even consider the possibility of just disbanding it, or allowing it to die a slow death, as too much time, energy and sacrifice has been placed in it! Despite the many fine people in NSLF, and despite the dedicated and qualified unit leaders, appointing a successor means that I would have to hand NSLF over to someone who has not demonstrated the ambition to lead. The danger here is that if a person has not demonstrated that ambition, how should I select him over someone else, or how am I to be sure that he can handle the responsibility? How would I know that NSLF would not die a slow death and all of our efforts would go for nothing? The gamble was too great. You and I deserve a sure thing. The Jews deserve a sure thing.

Our race demands a sure thing. The only logical solution to this dilemma appears to be a merger. I have given this much thought. I have gone over many possibilities. I have friends in many groups, but again, my decision is based upon what I believe is best for the movement. Hard times demand hard decisions, so, although I don't like the thought of relinguishing control to someone else, it must be done. As long as it must be done, I have chosen what I believe to be the best possible choice. The major consideration was to merge with an organization closest in posture to NSLF. The organization that meets that criteria is White Aryan Resistance (WAR), headed by Tom Metzger.

To be sure, Tom Metzger and I suree on every single ant lesue, that of White survival, we do agree. Furthermore, Tom is a dedicated individual, untainted by greed or scandal, and a professional in every sense of the word. He is a family man, a business man and a true revolutionary. With this in mind, I am encouraging all NSLF'ers to join and support Tom Metzger. In the past I could always depend on you to respond to your duty. 

Nations Report Aryan News From The Northwest

Beginning in the early months of 1986, Aryan Nations faced a serious treasonous attempt to discredit and eventually undermine and destroy Pastor Builer's lifelong labors. Fortunately the conspiracy failed, and those responsible are now behind bars, awaiting trial. Aryan Nations suffered only a momentary setback, and has resumed normal operation, and is stronger and more dedicated than ever, having learned an important lesson from it all.

The following list of events will describe the basic nature of the blueprint for treachery and should stand out as an example to all other movement factions who share in the struggle to awaken and instruct our people: For the past eight years, David and Debbie Dorr, a young married couple had been living in the Hayden Lake vicinity. They claimed they had moved from northern California where they had been involved in a survivalist parsmilitary group. Around the middle of 1985, Debbic began to volunteer her secretarial services to the church and would come in two or three times a week. Though the couple were allegedly experienced in police work as exsheriff's deputies and claimed to be registered private investigators, they never appeared to have full-time, regular employment, but always had money. If, in fact, surveillance was their game, we must ask ourselves to whom their surveillance was directed. What was their motive? And, who, if anyone, was backing them? These and many other questions will hopefully be solved in the final investigation.

The Dorr's took full opportunity to meet and circulate with anyone associated with Pastor Butler or who was even remotely involved with the movement. Everything went relatively smoothly until just after the Aryan Nations Congress, July 12 and 13, 1986. It appears that soon after the Congress was held, Debbie began a telephone campaign to discredit the good pastor and his organization, using his own telephone from his own office at church headquarters.

About August 5th a Robert Pires enters the scene from Maryland, where, it seems, he was running from a parol violation and stolen weapons charges. A recent case of AIDS backlash in America's heartland provides ample evidence that the AIDS epidemic may prove to be the Aryan Racialist Movement's greatest ally.

A news article in the System ress detailed the case of Mrs. worker employed as a nurse the Reno County Public Health Department in Hutchinson, Kanses. Mrs. Durr, a practicing nurse for over 14 years, was dismissed from her job by the Health Department after refusing to visit an AIDS patient in his home, in order to assess his home care needs. Although at first not thinking of refusing to perform this task as a necessary part of her employment, Mrs. Durr refused the sordid job after an evening of discussion with her husband, Duncan.

Mrs. Durr stated that her refusal was largely based upon the fact that "There are just too many unknowns. And we concerned about our family's well being." Mr. and Mrs. Durr are the proud parents of four

Mrs. Durr's dismissal comes after fourteen years of continuous employment. She is a woman who has never known unemployment. The incident, however, seems to have led her to the belief that accepting unemployment compensation is perhaps the only small course of action in retaliation for her ouster by a public entity she had so well served these many years.

"I felt like I had been hit in the gut and had all the air punched out of me", she stated. This was in response to the fact that the Public Health commissioner appeared at what was to be an "informal" hearing, armed with three System medical "professionals" who

testified to the sheer lunacy of Mrs. Durrs concerns. (This in the face of the Center For Disease Control figures which show that 1 in 20 AIDS cases have "No known/apparent" cause!)

"They tried to imply that I discriminating somebody. I'll tell you against anybody in my entire life", Mrs. Durr continued. Such responses are heard more frequently as the 200 system attempts to portray AIDS as a civil rights issue instead of the life-threatening pandenic that it is!

The Durr incident is only the first of cases such as this which will occur in the days ahead. Aryan racialists have by now come to the conclusion of the dire consequences emerging from the AIDS pandemic. But more importantly, the Durr incident points to the possibility of great gains for Aryan racialist action.

Margaret Durr has come face to face with the thin veneer of the ZOG System and all its lies. Perhaps spending her entire life without even questioning the underlying notions of continuous blood defilement and concepts of equality, Mrs. Durr has now accidentally clashed with the demon behind the mask of "humanitarian concern". Mrs. Durr has resigned herself to the fact that she may never work again. Such is the blackmail/hatred of the System for anyone who questions its doctrines of "equality" as interpreted through its blood-defiling practices.

Individuals such as Mrs. Durr are prime candidates for introduction to Aryan racialist ideas. At a time when all her world is collapsing, she needs to know that there are sympath-



umn represent's the writer's beliefs about conditions at the U.S. Penitentiary at Marion; it is not an actual memorandum from the Bureau of Prisons. It was written to mark today's third anniversary of the beginning of the lockdown at the prison.

tiary at Marion, Illinois. For three years, we have operated tarlon on lockdown. The goal of the experiment is control: to isolate the prisoner from any source of emotional support, increase his distrust

We limit contact with family and friends, and we listen to every word. We read all mail, coming and going. We limit telephone calls to 20 minutes per month, monitored and tape-recorded. I will try to recap the events around again. Four or five cars of armed men from the local Sheriff's Dept. and Federal Agents came racing into our yard on October 23, 1986. They did not identify themselves to me. I did not hear them read Rev. Gale his rights.

They arrived at 7.a.m. Rev. Gale was still in bed. He got up, put his bathrobe on and went out on the porch. At this time they put handcuffs on him, a chain around his waist and handcuffed his hands to the chain.

They took him to Fresno County Jail and put him and Rev. Parrino in an underground holding tank. Bill said it was like a dungeon. They were booked finally and Bill was put in the so-called Infirmary. This was a number of men in a cell lying on mats.

They had a couple of "bail hearings" in Fresno, however, it seems no one was listening. They were held without bail.

The charges on the indictment read: Conspiracy, Mailing Thratening Communications, Attempt to Interfere with the Administation of Internal Revenue Laws and Aiding and Abetting.

On October 27 after one of the so called hearings ending 12:30 p.m., they were put in a holding tank in the Federal Building. The T.V. news showed them taking them out some time after dark, and putting them in a van type vehicle. They were taken with all the haste to Lompoc, Ca. They were only wearing light weight jump quite provided by caught a terrible cold. They stayed in Lompoc until morning then flew on to Las Vegas.

These two men, career men, land owners and no previous records are being held without bail, even though to this date I have not been given one specific thing that either one has done personally to warrant such action!

etic individuals and organizations that recognize her plight. Margaret Durr is only the first of what will be a growing army of millions of Heartlanders who must sooner or later come face to face with the AIDS issue. On September 7th, Ed and Olive Hawley are arrested at the Spokane, Washington, Fairgrounds for passing counterfeit 20-dollar bills. Two other accomplices were seen in Kootenai County Idaho, but were not apprehended. Now things really began to move.

September 9th, Bob Miles, Richard Butler, and David and Debbie Dorr fly to Chicago to appear on the Oprah Winfrey TV Show. Debbie Dorr expresses anger that the program was intended to be exclusively for her and David but that at the last minute Pastors Miles and Butler muscled in on their action. The Dorrs went out of their way to make sure that Robert Pires attended that gala event, and he was as obvious in the audience as a stormtrooper at a Bar Mitzvah. By this time the suspicion of the Dorr's motives is reaching a

On September 15th a small pipe bomb explodes on the back porch of the Rev. Bill Wassmuth home with results being the viscious murder of his garbage can and the breakage of two windows, as shown in the November issue of LIFE magazine, page 28. Yes, indeed, the carnage was devastating, and The Most Holy Reverend was instantly made a celebrity and elevated to the position of candidate for Sainthood.

The media lapdogs, who had been previously sent from all corners of the nation, now had meat to feed on. How convenient it was that the media was there, and operating right on cue, just when things began to unwind. With a week of press orchestration of the bombing, Wassmuth's Human Rights Task Force held a rally at North Idaho College, Coeur d' Alene with more than a 700-participant turnout. What a coincidence! Things are quiet for a few

Then on September 26 a break-in and burglary occures at the Aryan Nations office. Someone obviously familiar with the entire operation at the church forces the office door and steals an Apple IIe computer and an armfull of software programs, cash money and checks, two video cameras and equipment, and a 35mm camera. Close to \$4,500.00 worth of equipment and cash was taken. The contraband was later discovered by police in the van of Robert Pires and in the Dorr's home workshop, while the Apple IIe was found in the Dorr's living room. Security on the church grounds could never have been breached except by someone familiar with the guard dogs and unique conditions at the facility. To date the property has not been returned by the authorities and

On September 28th the Human Rights Task Force sponsored another "revival" and 300 attend the tear-jerking extravaganza at the Westminster By this time the press has the entire Coeur d' Alene community Church. foaming at the mouth with hatred against their own racial flesh. The minorities are in ecstacy over their "Kill Whitey" fantasies and the ADL'ers are dancing in the street. Pastor Butler tries to calm the troubled waters by sponsoring a press conference to offer a reward for the apprehension of the bombers at the local county commissioner's "public" meeting room. The local press is happy to cover the meeting. The proposed meeting was to be a closed meeting for only Ruman Rights Task Force representatives and the media.

Saint Wassmuth and Company refuse to attend Pastor Sutler's press conference. and at the last minute the County Commissioners retract their permission to

to the masses to "hate the haters.

On September 29th Pastor Butler is scheduled to leave for Michigan to speak at the unnual meeting of Pastor Robert Miles. On that very same morning the Coeur d' Alene Blitz occurs - pipe bombs are mysteriously exploded at the Federal Building, The Luggage Rack, Jack's Family Dining, and there are phoned-in bomb threats to the Kootenai County Courthouse and Coeur d' Alene Post Office. One of the pipe bombs fails to detonate and leaves the feds with red hot evidence to work with. By this time the city (with the support of the ADL) is "outraged" and "incensed" by the obvious Aryan Nations terrorism. The police are totally stiffled and have nothing to go on except ADL accusations, screeching, and finger pointing. Then the simister plot comes crashing in on itself. It appears that the next phase of the conspiracy includes the assassination of Pastor Butler himself.

At this point Robert Pires (Black Bart) gets cold feet and envisions himself being put neatly away in a federal cage awaiting the Second Coming. He hits the panic button and runs to the feds to spill his guts. The very next morning the joyful caravan of 73 federal officers in 52 squad cars pull off a massive raid on the Dorr's country retreat. Bingo! They hit paydirt: over 50 firearms along with counterfeit money by the bundles are confiscated in the raid, and David Dorr is arrested on the spot. A second search of the property was conducted the next day and even more money and more guns were

found, including fully automatic machine guns.

At present Ed and Olive Hawley and David Door are facing conspiracy to manufacture, bombing, and counterfeiting charges and are in jail without bond, awaiting trial. Robert Pires is awaiting trial on bombing charges only. Debbie Dorr is suspected of being the key figure as an "unindicted coconspirator" in the operation. The Feds are making every effort to comher, but as yet are unsuccessful in making an arrest.

The FBI, local sheriff, press, and Wassauth's Task Force all know that Pastor Butler and Aryan Nations has had nothing to do with the entire vaudeville act, but the local and nationwide propaganda message insists that he was the leader of the pack, totally responsible for bombing his own backyard.

The Dorrs are not hopelessly insome people; they are very capable and intelligent. These questions must be asked: What was their ultimate objective? Who backed them for a year and a half or more? Was Pires a federal or ADL plant or operative? Were there any others? The entire episode is still under federal investigation; it will be very interesting to discover what comes of it all. At present the liberal rumor mongering, slanderous press attacks, and the anti-White propaganda continues. So we must assume that it is business as usual in the sleepy little north Idaho panhandle.

Ross used a fictitious name at a hospital and told Mohave County sheriff's investigators that a device he found along the road had blown up in his hand, Myers said. Sitver denied bail to Ross; Jack

Maxwell Oliphant, 63, owner of the 320-acre ranch where the explosion occurred; and Daniel Taylor Arthur, 30, a machinist and tax protester. Arthur, who formerly lived in Phoenix, had been living in a tent on Oliphant's ranch.

Arthur pointed a rifle at a helicopter carrying law-enforcement agents Monday when the ranch was raided, Myers said. Arthur's attorney contended Wednesday that the man only was using the rifle's telescopic sight to figure out who was in the helicop-

Arthur and his former wife, Theresa, were accused by Arizona revenue officials in 1984 of giving false information that led to their receiving erroneous refunds of \$2,514 on their state taxes, records in Maricopa County Superior Court

In fighting the accusation, Ar-thur challenged the validity of state and personal-income-tax laws. A Superior Court judge ruled against him in June 1985, and the Arizona Court of Appeals upheld the ruling in September, calling its claims

Bail was set at \$75,000 for Kingman auctioneer Patrick Henry Schlecht, 30, and \$25,000 for his wife, Rita. A bail hearing is set for today for Foster Thomas Hoover, 46, who owns a ranch about 20 miles northeast of Flagstaff.

Those six were named in three indictments issued Wednesday by a federal grand jury in Phoenix.

Several supporters of the Schlechts who attended the hearings declined to be interviewed, with one saying, "You couldn't print what I would say."

In the indictments, Oliphant, Patrick Schlecht, Arthur and Ross were accused of conspiring to commit a violent act - a planned robbery of an armored car on U.S. 93 after it left Laughlin, Nev., casinos, businesses and a bank with a weekend's haul. Explosives, a mixture of potassium chlorate, dynamite and axle grease, were to be used along with firearms, homemade explosive and a disabling gas, according to the indictment.

Oliphant and Taylor were accused of videotaping the prospective locations of the robbery attempt and the escape route in July and August.

In August, the indictment says, Ross, Arthur and Oliphant tested and demonstrated the use of exploding arrows and a homemade mortar that fired pipe bombs.

Oliphant, who lost his right arm above the elbow years ago in a firearms accident, also faces a charge of solicitation to commit a violent crime.

NAACP issues warning over racist show

Racism could erupt in Sacramento if a white supremist program continues to air on cable Channel 23, warned a group of community activists Friday.

Although they did not dispute the group's First Amendment rights to air their views on the community access channel, members of the Sacramento chapter of the NAACP vowed to fight the program with citizen pressure and television programs of their own.

Esther Nelson, president of the National Association for the Advancement of Colored People's local chapter, advised the 33,000 Sacramento cable, subscribers to "ignore" "Race and Reason," the two-part series produced by Tom Metzger, former dragon of the California Ku Klux Klan and sometime Democratic congressional

nominee in San Diego County. Although the program did not directly advocate violence against blacks, Nelson sald it could

Members of the Sacramento chapter vow to fight the program

trigger a "violent ripple effect" in the communi-

In 1923, the Ku Klux Klan first organized in Sacramento, Nelson said during the Friday morn-

ing news conference.
"At that time, we vowed arm and arm with leaders of the community to keep the Klan out of Sacramento," she said.

But in recent years, Nelson said many decision makers - "especially the Deukmejlan administration - have turned a deaf ear to the problems of racism."

"We are cailing on the community to bring about some sort of change," Nelson said. The group also called for a grand jury

investigation into the financial backing of "Race and Reason." If any public money was used to produce the

program, the public ought to know and respond accordingly, said Marcus Crowden, NAACP board

The first installment of the program was shown Nov. 21. It targeted the black race and expressed opposition to the black dean at American River College.

In the second installment - scheduled to air at 7 p.m. Friday - members of the Jewish community are criticized.

Immediately following the 30-minute program. the Sacramento Jewish Federation will present, "The Camera of My Family: Four Generations in Germany 1845 to 1945." It is one of three productions the Jewish group has submitted to the Sacramento Cable Foundation, which coordinates use of the public access channels.

The Fed's publication continues: "If we study one of these loans being made to a storekeeper, we can see how this checking account "deposit" creation takes place".

"Let us now see how the introduction of frozen orange juice might affect a storekeeper. He might, let's say, decide that he ought to carry a stock of frozen juice, and therefore he would have to get a freezer showcase. He might then go to his bank and ask for a loan of \$7,000 in order to buy the juice and showcase to hold and display it."

"The bank in making the loan, would not give the storekeeper ten-dollar bills, but would, via the bank's accounting or bookkeeping procedure credit his checking account with \$7,000 of checking account "deposit" checks on those created checking acount deposit credits to pay for the showcase and the juice".

Pertinent to the above text, a 1964 House Banking and Currency committee publication, printed for the use of the Committee on page 6 poses the following questions:

Do private banks issue money today?

Yes. Although the banks no longer have the right to issue (print) bank notes, they can create money in the form of bank deposits when they lend money to business, or buy securities. The important thing to remember is that when banks lend money they don't necessarily take it else to lend (spend or invest). Thus they "create"

The Fed's publication continues: "This created "deposit storekeeper's checking account is a "deposit" in the bank, just as much as a deposit you or I might make by pushing a ten-dollar bill across the teller's window and converting that ten-dollar bill into "deposit credita" money.

'The bank holds itself liable to pay out our ten-dollar deposit, if we draw a check against it, just exactly as it holds itself liable to pay out the storekeeper's "deposit" if he should draw a check against

At this point it becomes VERY IMPORTANT TO UNDERSTAND what is meant by: "the bank holds itself liable to pay". That bank statement is LOADED with specious implication to the financial students and the general public. That bankers' traditional statement "promise to pay" or "the bank holds itself liable to pay" simply means that the bank account "deposit credits" as ordered by the storekeeper's checks drawn upon his "bank created" deposit credits.

The Fed's publication "MONEY; Master or Servant" explains it this way: "It is important to note that, while your (storekeeper's) check is an order to your (storekeeper's) bank "to pay to the order of" so-and-so a certain sum of money (dollars and cents), it is not necessary for the bank to pay cash currency and coin to so-and-so. More often than not, the bank simply charges the sum of the checks against your (storekeeper's) checking account and credits the sum to another account."

And, in summary, the Fed's publication puts it this way: "Commercial banks, in short, normally extend (via bookkeeping procedure) credit to the borrowers in the form of "deposits" into the borrowers' checking accounts, and these deposits become additions to the M-1 money supply in our economy", "When the borrowers pay interest and repay their loans to banks, they use the money in their checking accounts to make the payments. Thus the banks destroy (extinguish) the money they created"

Mr. Robert H. Hemphill, 8 years Credit Menager of the Federal Reserve Bank of Atlanta in (1/24/39) Senate Document #23 on page 102 states:

"If all the bank loans were paid off, no one would have a bank deposit and there would not be a dollar of coin or currency in circulation. This is a staggering thought. We are completely dependent on the commercial banks for our money. Someone someplace had to borrow from a commercial bank, every dollar of money we have in circulation, cash or deposit oredits. If the banks create ample (deposit credits) synthetic



money we are prosperous; if not, we starve. We are absolutely without a permanent government money system. When one gets a complete grasp of the picture, the trugic absurdity tion, it is almost incredible. but here it is ignored by our leaders and public officials. The private deposit credits money creating monopoly in our midst, is the most important subject concerned and intelligent persons can investigate and reflect upon. It is so imortant that our present western free enterprise civilization may collapse unless the bank deposit credits money creating monopoly becomes widely understood and the defects remedied soon."

Murder Rates: Dangerous Cities

ach year, the FBI compiles a statistical in the U.S. Based on numbers in the FBI's latest 368-page study, our totals show that Detroit overtook Gary, Ind., last year as the major city with the highest murder rate in the nation—58 per 100,000 inhabitants. Gary had 43 per 100,000.

Some other cities with inordinately high homicide rates in 1985 were Richmond, Va., with 41.5 murders per 100,000 people; St. Louis, with 39; Newark, N.J., with 37; and Birmingham, Ala., and Miami, tied at 34 per 100,000. Flint, Mich., had a 31.5 homicide rate, while Dallas and Fort Worth were tied at 30.

Three cities where gambling is legal showed the following murder rates: Atlantic City, N.J., 18.4 murders per 100,000; Las Vegas, 12.5; and Reno, 8.3.

Dear Tom.

I wrote down a few things concerning the problems of an inmate and his family. Fighting the Bureau of Prisons and like minded organizations is a tough road to hoe. But nobody ever said this game would be easy. I, for one, sincerely appreciate your efforts. As you are aware, there is a constant psychological onslaught against an inmate. Especially their handusually one thing after another and many times multiple head games at once. I can see the "officials" in their offices laughing as they pull the strings on their puppets. You've got to hand it to them, they are experts at what they do. And of course it's all designed so they can tell you how to think. Ha! You've heard it all before. They'll stimulate you a little this way - analyze your reacion - then stimulate you a little that way - again analyzing. Oh - but they don't have time for all that - I've heard people say. I say the hell they don't. They are truly game mas-ters. The immate must be aware of this and not allow their games to get to him. As in any survival situation, strength is imperative. Keeping a cool head is also imperative. You've got to know when to absorb, when to react or not re When to flow with the punch and when to punch back. An innate must constantly be aware of their games. It's the same movecountermove game as out there only here you're under their direct control and the game is therefore intensified. I have learned much - they are good teachers.

The whole thing honestly doesn't seem like reality. I'm just here in some temporary dimension. It's a trip. I can honestly separate my spirit from my carnal, What I'm saying is the old saying "They've got my body, but they'll never get my mind." Because my mind is free and separate from my body.
